

## CITY OF TERRACE

### BYLAW NO. 1981 – 2011

**"A BYLAW FOR THE CITY OF TERRACE FOR LEVYING RATES FOR MUNICIPAL GENERAL, DEBT AND TRANSIT, REGIONAL HOSPITAL DISTRICT, AND REGIONAL DISTRICT ADMINISTRATION AND GENERAL GOVERNMENT PURPOSES FOR THE YEAR 2011."**

**WHEREAS** pursuant to the provisions of the Community Charter the Council shall, on or before the 15th day of May in each year, adopt a Bylaw or Bylaws for imposing upon all land and improvements, according to the assessed value thereof, a rate or rates for Municipal General, Debt and Transit, Regional Hospital District, and Regional District Administration and General Government purposes.

**NOW THEREFORE** the Council of the City of Terrace, in open meeting assembled, enacts as follows:

1.0 The following rates are hereby imposed and levied for the year 2011:

- a) For all **general purposes** of the Municipality, on the assessed value of land and improvements taxable for general municipal purposes, rates appearing in **Column "A"** of Schedule "A" attached hereto and forming a part hereof;
- b) For **debt purposes**, on the assessed value of land and improvements taxable for general municipal purposes, rates appearing in **Column "B"** of Schedule "A" attached hereto and forming a part hereof;
- c) For **transit services**, on the assessed value of land and improvements taxable for hospital purposes, rates appearing in **Column "C"** of Schedule "A" attached hereto and forming part hereof;
- d) For **purposes** of the **Regional District of Kitimat-Stikine**, on the assessed value of land and improvements taxable for hospital purposes, rates appearing in **Column "D"** of Schedule "A" attached hereto and forming a part hereof; and
- e) For **hospital purposes**, on the assessed value of land and improvements taxable for hospital purposes, rates appearing in **Column "E"** of Schedule "A" attached hereto and forming a part hereof.

2.0 This Bylaw may be cited as "**2011 Tax Rate Bylaw No. 1981 – 2011**".

**READ a second time** this 26<sup>th</sup> day of April, 2011.

**READ a third time** this 26<sup>th</sup> day of April, 2011.

**ADOPTED** this 9<sup>th</sup> day of May, 2011.
