# **DELEGATIONS & GUESTS:**

Amanda Owens, Ksan House Society – Request for Resolution of Support for a Grant Application to Northern Development Initiative Trust Mayor Leclerc welcomed Ms. Owens of Ksan House Society (Ksan) to the Council meeting.

The application was submitted to the Northern Healthy Communities Capacity Building Fund. Ksan would like to implement a Mental Health Outreach Worker position that would liaise between Northern Health and Ksan to help support individuals in supportive housing and emergency shelter programs. This position would help those struggling with mental health and addictions issues.

Ksan has applied to Northern Development Initiative Trust as the intake deadline was February 26; however, Northern Development Initiative Trust will allow for a resolution of support from the City after the application has been submitted.

This position would require a clinician level of education regarding mental health and addictions. They would be able to perform initial assessment on individual living in Ksan's housing programs and those accessing their shelter programs. This position would be able to make the initial connection with Northern Health. They would also be able to connect individuals to the right supports.

Northern Health has already provided a letter of support for their application.

Ms. Owens requested that Council provide a resolution of support for their grant application to Northern Development Initiative Trust's Northern Healthy Communities Fund for a Mental Health Outreach Worker to support individuals accessing our emergency shelters and living in our supportive housing programs.

This position could be a nurse or someone with a mental health social worker background. The successful applicant would be someone who has the skills and education to perform initial assessments of clients.

As this funding is only for one year, Ksan hopes to reapply the following year for further grant funding. They feel that this position is a need in the community. If Ksan is unable to reapply for a second year of funding, they would seek other funding avenues in order to keep this position in place.

This position would complement Northern Health's Intensive Case Management Team.

Mayor Leclerc thanked Ms. Owens for her presentation and advised that the matter would be further dealt with under the "Correspondence" portion of this meeting's Agenda (See Resolution No. 103).

- Summer, co-op students, or youth: FireSmart education projects (door knocking, pamphlets, events, etc.);
- Neighbourhood champions undertaking activities required for FireSmart Canada Neighbourhood Recognition; and
- ➤ Training, including training specific to youth, to support FireSmart projects and fuel management demonstration projects such as Basic FireSmart Landscaping and Basic Power Saw Safety;

And that staff be authorized to provide overall management of the project.
