## **DELEGATIONS & GUESTS:**

Jay Layman, Seabridge Gold - KSM Project Update MOVED/SECONDED to move In-Camera and close the meeting to the public pursuant to Division 3, Sections 90 (1)(a) and (e) of the Community Charter to discuss matters relating to personnel and property.

Mayor Pernarowski advised that the City's Talkback Line is available for any comments or concerns viewers of this meeting may wish to bring to the attention of Council. He further advised that Council agendas and minutes are available for viewing on the City's home page at www.terrace.ca.

Jay Layman is the Chief Operating Officer of Seabridge Gold. Seabridge Gold is a Canadian company with two major projects, KSM in B.C. and Great Slave Lake in the Northwest Territories. The KSM project is located west of Bell II. Since the discovery of the Mitchell deposit there, and with the development of the Northwest Transmission Line, the project has become economically viable. KSM is the second largest undeveloped gold/copper project in the world. Seabridge Gold plans to ship their copper concentrate ore out of the Port of Stewart.

The area at the KSM site is naturally very acidic and operating a mining project would require the water to be treated so the water in the area will actually improve from its current condition due to the mining

project. Seabridge Gold is committed to having open dialogue with First Nations and working with First Nations on the project.

The KSM Working Group meets in March to review the project's final operating parameters and they intend to make their application to the Environmental Assessment Office in October 2012. They hope to start construction in 2013 and have operation of the mine commence in 2018. This large scale mining operation will directly employ about 1,000 people and indirectly employ over 1,000. Seabridge Gold estimated 4,000 to 5,000 people would be employed for construction.

Mayor Pernarowski thanked Mr. Layman for his presentation, and advised that this matter would be further dealt with under the "Correspondence" portion of this meeting's Agenda (see Resolution No. 072).

Dorothy Bartsoff, BCGEU – Community Social Services Awareness Month Ms. Bartsoff introduced herself as a Community Social Services Worker and B.C. Government and Services Employees Union representative. She thanked Council for the opportunity to present regarding Community Social Services Awareness Month. This campaign is held across B.C. to raise awareness of the work of community social services workers.

Ms. Bartsoff asked Council to pass a resolution which indicates Council is aware March is Community Social Services Awareness Month and to recognize the value of the services provided.

Ms. Bartsoff will be organizing a display table to be located at the Skeena Mall Community Room on Friday, March 16.

Mayor Pernarowski thanked Ms. Bartsoff for her presentation, and advised that this matter would be further dealt with under the "Correspondence" portion of this meeting's Agenda (see Resolution No. 073).

Carman Hendry, Northwest Regional Airport Terrace-Kitimat – Request for Resolution of Support Carman Hendry, Airport Manger for the Northwest Regional Airport Terrace-Kitimat, thanked Council for the opportunity to present. Mr. Hendry requested a resolution of support from the City of Terrace for the Airport Society's application to Northern Development Initiative Trust for \$100,000 in grant funding.

The Airport Society would like the funding to expand their apron at the Airport. As a result of all of the projects starting up in the Northwest, they anticipate greater numbers of passengers and larger planes which may not fit well inside the existing apron stands. 600 additional passengers a week are expected related to construction projects in Kitimat.

To accommodate larger planes the Airport Society would like to add a 150 m piece of asphalt on the east side of the apron, relocate stand number three, and add a fourth stand. In the summer months they require three stands but only have room for two, so they have received permission from Transport Canada to extend the restricted area through the use of security personnel to accommodate three planes.

The second component of their project is to replace 13 ducts that run under the runways and the third component of the project would be to develop an area for the snow removal equipment to exit the runway near the junction of the runways.

The total budget is \$1,115,500. They are applying to Northern Development for \$100,000; Western Development for \$530,000; and the Airport Society would pay \$485,500. Terrace currently has \$320,000 available in the Northern Development funding.
