1.PERMANENT CLOSURE AND REMOVAL OF HIGHWAY DEDICATION BYLAW (INDUSTRIAL WAY)

It was recommended that the Bylaw to permanently close and remove the highway dedication of the road area totaling 9.73 hectares for Industrial Way, dedicated as highway by Plan EPP19161, District Lots 1725 & 1726, Range 5, Coast District and that the closed highway lands are disposed of to the adjacent commercial property owners proceed to Council for consideration.

2. ZONING AMENDMENT – FROESE (4934 TWEDLE AVENUE)

It was recommended that the Bylaw to amend Zoning Bylaw No. 1431-1995 by changing the zoning designation from AR2 - Rural to R1 - One Family Residential for the property legally described as Lot B, District Lot 979, Range 5, Coast District, Plan 3795 (4934 Twedle Avenue) proceed to Council for consideration.

3. DEVELOPMENT VARIANCE PERMIT NO. 02-2014 - MCCOLMAN (3408 MUNROE STREET)

It was recommended that Development Permit No. 02-2014 be issued for the property located at 3408 Munroe Street (Lot A, District Lot 362, Range 5, Coast District, Plan 5149), including the following variance:

➤ To vary Section 6.1.3.9 of Zoning Bylaw 1431-1995 and amendments thereto shall be varied to reduce the minimum principal building size of a two storey building in the R1-One Family Residential zone from 140 square metre to 123 square metres.

4. DEVELOPMENT VARIANCE PERMIT NO. 03-2014 - ARMSTRONG (2503 SKEENA STREET)

It was recommended that Development Variance Permit No. 03-2014 be issued for the property located at 2503 Skeena Street (Lot 8, District Lot 615, Range 5, Coast District, Plan 4539), including the following variances:

- To vary Sentence 4.18.3 of Zoning Bylaw No. 1431-1995 and amendments thereto to reduce the setback from the natural boundary of the Skeena River from 60.0 metres to 48.5 metres to allow the construction of an attached garage as an addition to the existing dwelling. The rear (west) foundation and wall of the addition shall be constructed no closer to the natural boundary of the Skeena River than the existing dwelling's foundation; and
- ➤ To vary Sentence 10.3.3.3 of Zoning Bylaw 1431-1995 and amendments thereto to reduce the minimum setback for a front parcel line from 7.5 metres to 5.5 metres to allow the construction of an attached garage as an addition to the existing dwelling.

5. DEVELOPMENT PERMIT NO. 04-2014 - 881511 BC LTD. (5023 & 5025 KEITH AVENUE)

It was recommended that Development Permit No. 04-2014 be issued to 881511 BC Ltd. for the property legally described as the West ½ of Lot 6 and the East ½ of Lot 7, Block 2, District Lot 369, Range 5, Coast District, Plan 1992 (5023 & 5025 Keith Avenue) to permit the development of mini warehouse/storage units.
