You are responsible for ensuring that your completed ballot and any supporting documentation is received at the City of Terrace office no later than 4:00 p.m. on Friday, November 14, 2014; or hand-delivered or couriered to the Chief Election Officer at the Terrace Sportsplex Banquet Room, 3320 Kalum Street, and received no later than 8:00 p.m. on General Voting Day, Saturday, November 15, 2014.
