DELEGATIONS & GUESTS:

Ed Carreiro – Loomis Noise & Light Update Mayor Leclerc welcomed Mr. Ed Carreiro to the Council meeting.

Mr. Carreiro resides across the street from a busy commercial property and presented to Council over a year ago to request that Canadian Freightways erect a noise and light barrier. At that time, Council referred the matter to Administration; however Mr. Carreiro says not enough has been done to address the issue.

Plastic slats were put in the chain link fence separating the two properties, but Mr. Carriero said he feels not enough has been done to minimize the rooftop halogen floodlight shining into his home all night or the sounds from trucks loading and unloading in the warehouse.

Mr. Carreiro has spoken with Development Services staff and was told the noise bylaw doesn't apply to commercial lots adjacent to neighbours. The owner of the building changed the angle of the rooftop light just last week, but Mr. Carreiro said it's even worse now and shines directly onto his property. Mr. Carreiro passed out pictures of the fence and light.

Mayor Leclerc thanked Mr. Carreiro for his presentation and advised the matter would be further dealt with under the "Correspondence" portion of this meeting's Agenda. (See Resolution No. 035).

Barry Prince – Dangers of Fluoridated Water

Mayor Leclerc welcomed Mr. Barry Prince to the meeting.

The American Dental Association just released a report that stated children under 6 receive very little benefit from fluoridated water. Fluoride is believed to be a neurotoxin that has a cumulative effect on the body and Mr. Prince says it's been proven to lower I.Q., and increases the chance of arthritis and cancer.

There are only 4 communities in British Columbia that still fluoridate their water, with Terrace being one. Mr. Prince requested that Council look at a process to cease adding fluoride to the City's water.

Mayor Leclerc thanked Mr. Prince for his presentation and advised the matter would be further dealt with under the "Correspondence" portion of this meeting's Agenda. (See Resolution No. 036).

Mayor Leclerc welcomed Rotary Presidents Lisa Novich and Kelly Gingles to the Council meeting.

Presidents Lisa Novich & Kelly Gingles, Rotary Clubs of Terrace – Rotary Splash Park Proposal

The Rotary Clubs of Terrace have earmarked funds to install a splash park for children. Many splash parks in communities across BC have been a result of collaborative efforts with local Rotary Clubs and the Rotary Clubs of Terrace would like Council to consider having the splash park installed right in Spirit Square at George Little Park, beside the Kin Park to make it accessible to all socio-economic groups.

Rotary would like to install the splash park and have the City govern and maintain it. The nozzles would be low-flow and expected water usage is estimated to be between approximately 4-9 homes worth of water consumption annually. City staff has requested the use of dry wells to return the water to the ground. Long-term maintenance costs are approximately \$1,000/year to maintain a spray park of similar size in Merritt, BC. If the City chooses to remove the above ground structures for winter, there may be additional costs.

The plan is to build a 1,500 square foot splash pad that will cost under \$250,000. Rotary will be connecting with several local businesses and industries to fundraise and will be seeking grants as well as crowdsourcing funds.

There were concerns that George Little Park was running out of green space and Council wondered if Rotary had considered putting the splash park on the south side of town. Rotary Presidents Gingles and Novich explained that George Little Park is the preferred location as it's our premier City park that is fully accessible to all socio-economic groups, it's accessible by public transportation, and it's near other City infrastructure.

The goal is to have the splash pad ready for the summer of 2016. The Rotary Clubs asked Council to indicate their support for the project and the proposed location.

Mayor Leclerc thanked Ms. Novich and Mr. Gingles for their presentation and advised the matter would be further dealt with under the "Correspondence" portion of this meeting's Agenda. (See Resolution No. 037).
