Mayor Leclerc acknowledged that due to the latest public health orders prohibiting the public from attending Council meetings in person, Council was providing the media and members of the public an opportunity at the end of the meeting to comment or ask questions pertaining to items on the Council meeting agenda.

It was further explained that participation could be had by joining the virtual Microsoft Teams meeting through a computer, mobile device, or regular telephone call. Mayor Leclerc acknowledged that the meeting was being held on the traditional unceded homelands and territory of the Tsimshian First Nation. She also advised that Council agendas and minutes are available for viewing on the City's home page at www.terrace.ca, that the Council meeting was being livestreamed on the City's Facebook page, and that the past minutes have been archived.

Acknowledgement of the resignation of Councillor Jessica McCallum-Miller

Mayor Leclerc acknowledged that Councillor McCallum-Miller had submitted a letter of resignation on February 22, 2021.

Acknowledgment of the passing of former Mayor Gordon Rowland

Mayor Leclerc acknowledged the passing of former Mayor Gordon Rowland. She shared some of Mr. Rowland's many accomplishments and offered condolences to his family.

Acknowledgement of Registered Building Officials Mayor Leclerc acknowledged Leo Francisco and Nathan Brooks, City of Terrace Building Officials, for their accomplishment of obtaining their Level 3 Certification as Registered Building Officials through the Building Officials' Association of BC.

DELEGATIONS & GUESTS:

Amanda Horvath, Paul More, Rhonda Mellafont, and Aaron Nugent – Landslide Erosion & Mitigation Efforts on McConnell Crescent, Request for the City of Terrace to Apply for UBCM Grant Mayor Leclerc welcomed Ms. Horvath, Mr. More, Ms. Mellafont, and Mr. Nugent to the Council meeting.

Ms. Horvath was speaking on behalf of herself and her husband, the Mores, and the Nugents. Paul More was also present to represent his family, as was Daniel Talstra who was representing his family.

Ms. Horvath request that Council grant urgent and immediate assistance by providing agreement and direction to city staff to complete the required applications for funding to mitigate damage of the slide and subsequent erosion behind the properties on McConnell Crescent and Stellars Jay Drive and prevent further damage or loss. Ms. Horvath noted that Union of B.C. Municipalities' Community Emergency Preparedness Fund Flood Risk

Assessment, Flood Mapping & Flood Mitigation Planning grant would be closing February 26, 2021 and would not be available again until 2022. The Mores have had extensive property loss and as of December 2020 both neighbouring properties have had small portions of their properties also erode due to the landslide.

Tim Smith spoke to the Preliminary Landslide Assessment that was completed by Westrek Geotechnical Services Ltd. for the property at 5414 McConnell Crescent.

In April or May 2019, a landslide occurred at the back of the property at 5414 McConnell Crescent. It was likely triggered by erosional scour from the Kitsumkalum River. It has moved about one kilometre in the last 80 years. Enough soil was removed from the bottom of the slope behind the More property that the slope failed. The ongoing erosion will continue to eat into the bank and slope.

The size of the landslide is also being increased by groundwater seepage coming out of the landslide path. This is causing soil to be removed by the groundwater that is coming out. This also causes the landslide to move further back.

Initially this landslide only impacted the More property at 5414 McConnell Crescent; however, it has now expended to portions of 5412 and 5416 McConnell Crescent.

The main causes of the slide include:

- Erosion driven by the river; and
- Groundwater seepage that is coming out of the landslide path below the property.

It is difficult for individual homeowners to apply for protective measures to be applied to the base of the river. There are substantial rules and regulations in place to have these protective measures applied.

In 2017 there was a slide to the south of 5416 and 5418 McConnell Crescent. At that time, the City applied a rock filled blanket across the length of the

slope. The approach to control the groundwater would be similar. In the landslide area, due to climate change, there will likely be more problem occurring along the bank of the Kitsumkalum River which could continue to effect adjacent properties. Mr. Smith felt that this could be part of a broader study to potentially install riprap at the bottom of the slope to help with mitigation.

It is difficult for individual homeowners to get this issue pushed forward. Local government has a better chance of working with the Province to move this type of issue forward.

Mayor Leclerc thanked Ms. Horvath and Mr. Smith for their presentation and advised that the matter would be further dealt with under the "Correspondence" portion of this meeting's Agenda (See Resolution No. 078).
