# MINUTES OF THE REGULAR COUNCIL MEETING HELD IN THE MUNICIPAL COUNCIL CHAMBERS ON MONDAY, JUNE 13, 2011 AT 7:35 P.M.

Mayor D. Pernarowski presided. Councillors present were L. Christiansen, B. Downie, C. Leclerc, B. Martindale and B. Pollard. Councillor B. Bidgood was absent. Also in attendance were R. Poole, Chief Administrative Officer, M. Kwiatkowski, Director of Development Services, D. Block, City Planner, H. Nunn, Clerk and A. Thompson, Executive Assistant.

### **DELEGATIONS & GUESTS:**

Don Ramsay, Ministry of Transportation District Manager – Ministry Update Mr. Don Ramsay, District Manager for the Skeena District of the Ministry of Transportation and Infrastructure, gave an update of their projects for 2011.

This is public service week for the Provincial Government and people in the public service are recognized for their work. On May 31, 2011, the Greater Terrace Traffic Safety Committee was honoured in Victoria. There are a number of organizations represented on the Committee, including the City of Terrace. As a result of the work of the Committee there has been an increased interest in traffic safety and each of the group members has brought their specialized knowledge to become advocates for road safety. Mr. Ramsay displayed a chart indicating the annual number of crashes in the Skeena Region, and highlighted the dramatic reduction in crashes over the past five years. Mr. Ramsay estimated that a reduction in the number of crashes means there has been a savings of \$2.65 million per year for the past five years. These savings are immeasurable compared to the

human costs of crashes.

The Committee was nominated by the Assistant Deputy Minister for the Premier's Award for Organizational Excellence and was a finalist in that category. Mr. Ramsay presented Don Murray, Staff Sargent, Terrace R.C.M.P., and Herb Dusdal, Director of Public Works, City of Terrace, each with framed certificates from the Premier.

Mayor Pernarowski thanked Mr. Ramsay for his presentation, and advised that this matter would be further dealt with under the "Correspondence" portion of this meeting's Agenda (see Resolution No. 227).

Jill Springer, Skeena Diversity Society – Diversity Health Fair Jill Springer has been hired by Skeena Diversity Society to organize Terrace's first Multicultural Health Fair. She introduced the Skeena Diversity Health Fair team present at the meeting: Jane Dickson, Sasa Loggin, Debbie Buxton, Susana Reyes and Esperanza Cortez.

Ms. Springer invited Council to attend the Diversity Health Fair, which will be held on Saturday, June 18 at the Skeena Mall. The goal of the Fair is to raise awareness of the entire spectrum of health care choices in Terrace. Ms. Springer also invited Mayor and Council to the Opening Ceremonies on Friday, June 17 at the Evangelical Free Church.

Mayor Pernarowski thanked Ms. Springer for her presentation and advised that this matter would be further dealt with under the "Correspondence" portion of this meeting's Agenda (see Resolution No. 228).

Jessica McCallum-Miller, 24-Hour Youth Centre Committee – Youth Homelessness Awareness Hunger Strike Jessica McCallum-Miller, a student at Parkside Secondary School, thanked Council for the opportunity to present. She introduced Sandy Watson who presented with her.

Ms. McCallum-Miller proposed holding a 24-hour hunger strike on July 8/9 to raise awareness of the issue of homeless youth and to fundraise for homeless youth in the community. They would like to have a camp out on the Millennium Trail and are

seeking permission from Council.

Ms. McCallum-Miller estimates that over 100 people are willing to participate in the hunger strike and camp out. There will be signage to help raise awareness of the issue of youth homelessness. Organizers will be asking for port-a-potties and for police support to patrol as well as collecting pledges and looking for donations of supplies. It will be an alcohol-free event and there will be adults chaperoning the camp out for the duration of the event.
