MOVE TO IN-CAMERA SPECIAL COUNCIL:

Mayor Leclerc opened the meeting by welcoming everyone and thanking City staff, contractors, emergency responders, and the community for the major snow removal effort after a recent snowstorm.

Mayor Leclerc introduced MP Nathan Cullen who briefly addressed Council.

Mayor Leclerc thanked Mr. Cullen for attending the meeting and advised that Council agendas and minutes are available for viewing on the City's home page at www.terrace.ca and that Council meetings are webcast on the City's website and the past minutes have been archived.

DELEGATIONS & GUESTS:

Ron Bee, Terrace Peaks Gymnastics Club – Rental Waiver Request The Terrace Peaks Gymnastics Club has been in the community for 40 years and on September 26, 2015, the club is having a major fundraiser at the Terrace Sportsplex. Alumni from the Vancouver Canucks hockey team will be flown to Terrace to play a charity game with proceeds going to the Terrace Peaks Gymnastics Club.

It will cost the club approximately \$2,765 to rent the facility for the event and Mr. Bee requested a rental waiver from Council.

All Seasons Sports will be providing corporate support by donating an allotment of tickets for families who can't afford to attend this fundraising event.

Mayor Leclerc thanked Mr. Bee for his presentation and advised the matter would be further dealt with under the "Correspondence" portion of this meeting's Agenda. (See Resolution No. 055).

John Farrell, Community Futures – Northwest Growth Conference In addition to being the General Manager of Community Futures Pacific Northwest in Prince Rupert, Mr. Farrell is President of the Prince Rupert Chamber of Commerce and a small business owner.

Mr. Farrell gave an overview of the Northwest Growth Conference taking place March 6 & 7 in Prince Rupert and asked Council to sponsor the event.

Mr. Farrell hopes this becomes an annual event and reminded Council that the early bird deadline is February 14, and after that the cost to attend rises from \$175 to \$225.

Mayor Leclerc thanked Mr. Farrell for his presentation and advised the matter would be further dealt with under the "Correspondence" portion of this meeting's Agenda. (See Resolution No. 056).

Nichola Wade, Community, Sport & Cultural Development – Northwest Readiness Project Update As the Deputy Inspector of Municipalities, Mr. Schlosar spoke about the recent elections, the Local Government Leadership Academy Training available for Local Government politicians and a number of funding opportunities.

The New Building Canada Fund – Small Communities Fund grant deadline is in a week and the Gas Tax Fund intake deadline for special infrastructure projects is in April.

With regard to the Northwest Readiness Project, a real emphasis has been placed on capacity building and planning and it was noted that the City received funds for asset management planning, Neighbourhood Concept Plan, as well as funding for an assessment of our wastewater treatment plant and water utility master plan.

The next step in the Northwest Readiness Project is to create a roundtable with some of the Provincial agencies to create a forum of collaboration.

Mayor Leclerc thanked Mr. Schlosar for his presentation and advised the matter would be further dealt with under the "Correspondence" portion of this meeting's Agenda. (See Resolution No. 057).

Carman Hendry, Terrace-Kitimat Airport Society – Request for Letter of Support for Building Canada Fund Passenger traffic at the airport has increased 49% over the last 12 months and the Terrace-Kitimat Airport Society is requesting a resolution of support for their application to the Building Canada Fund to renovate the facilities.

The Society wishes to apply for \$15 million from the Federal Government's Building Canada Fund to increase the size of the facility from 2,570 square metres to 4,100 square metres. In addition, there will be new offices for airlines, new check-in counters, three gates and a holding room that will hold 300 people.

Mr. Hendry requested a resolution of support from Council to provide a letter of support for the Society to the Building Canada Fund. Mayor Leclerc thanked Mr. Hendry for his presentation and advised the matter would be further dealt with under the "Correspondence" portion of this meeting's Agenda. (See Resolution No. 058).
