Ted Ramsey, Regional District of Kitimat-Stikine Board Director of Electoral Area E – Thornhill, thanked Council for the opportunity to present regarding the incorporation of Thornhill.

Mr. Ramsey stated an application to incorporate Thornhill has been submitted to the Ministry of Community, Sport, and Cultural Development and that it takes approximately three years to go through the process of incorporation.

The primary reason Thornhill is looking to incorporate is to have access to Provincial Government Ministers to be able to advocate for the citizens of Thornhill. To date, Mr. Ramsey has only received one piece of correspondence from a constituent that stated

perhaps incorporation wasn't a good idea.

Mr. Ramsey stated that it was time for Thornhill to incorporate and that he hoped Terrace would support this as two communities who wish to grow together.

When asked about the costs of incorporation, Mr. Ramsey stated that there is a lot of room for development in Thornhill and that the Northwest Revenue Benefits Alliance may help defray some cost.

Mayor Pernarowski thanked Mr. Ramsey for his presentation and said the matter would be further dealt with in the "Correspondence" section of this meeting's Agenda. (See Resolution No. 524)

Lael McKeown – Terrace & Thornhill... Next Steps

Lael McKeown thanked Council for the opportunity to present.

Ms. McKeown said an option to Thornhill incorporating would be to restructure Terrace, including amalgamation and border extension to include Thornhill.

Ms. McKeown stated Terrace should research amalgamation and that residents of Terrace and Thornhill should have all the facts regarding incorporation and amalgamation before putting it to a referendum vote.

Amalgamation would promote a common bond between the two communities rather than competition, and would solve the issue of Terrace being land-locked.
