## <u>DELEGATIONS & GUESTS</u>:

Kerensa Medhurst and Helen Owen – Canadian Cancer Society, Cosmetic Pesticides MOVED/SECONDED to move In-Camera and close the meeting to the public pursuant to Division 3, Sections 90 (1)(b) and (e) of the Community Charter to discuss matters relating to personnel and property.

Mayor Pernarowski advised that the City's Talkback Line is available for any comments or concerns viewers of this meeting may wish to bring to the attention of Council. He further advised that Council agendas and minutes are available for viewing on the City's home page at <a href="https://www.terrace.ca">www.terrace.ca</a>.

There was no Addendum.

Representing the Canadian Cancer Society were Kerensa Medhurst, Health Promotion Coordinator, and Helen Owen, Community **Fundraising** Coordinator. The Canadian Cancer Society's mandate is the eradication of cancer and to improve the quality of life for people living with the disease. Half of all cancers can be prevented through behavioural changes. The Canadian Cancer Society would like to see pesticide use reduced in the community as there is a correlation between pesticide use and the incidences of cancer. They requested that Council consider implementing a pesticide bylaw to reduce the public's exposure to unnecessary pesticides.

Ms. Medhurst explained that children are particularly vulnerable to the effects of pesticides and that pesticides are difficult to contain as they are distributed through the soil, air and water. 168 Canadian municipalities have adopted and/or implemented pesticide bylaws and the Province of BC is considering a Provincial ban. Enforcement could be done on a complaint basis and there would be an educational component to the bylaw, although education is not effective enough on its own to significantly reduce cosmetic pesticide usage.

Mayor Pernarowski thanked Ms. Medhurst and Ms. Owen for their presentation, and advised that this matter would be further dealt with under the "Correspondence" portion of this meeting's Agenda (see Resolution No. 047).

Debbie Letawski – George Little House & Little House Enterprise Ms. Letawski thanked Council for the opportunity to present. She introduced George Little House staff lone Nicholson and Donna Stach. Ms. Letawski described the mandate of the George Little House. In addition to providing their usual service to VIA Rail passengers, the George Little House staff assisted in the 2010 BC Winter Games, provided work experience opportunities for high school students, and supported a number of community events and societies throughout the year.

Ms. Letawski is concerned about the deterioration of the area where the George Little House is located. Now that the restaurant in the nearby Best Western Hotel has closed there is less local traffic. There has been an increase in garbage, vandalism and theft in the area which has had a negative effect on the George Little House. Ms. Letawksi requested that Council consider eliminating the 5% and 10% commissions from the Little House Enterprise Management Fee Contract that currently go to the City, and requested that the lease for the House not be increased.

Ms. Letawski feels that fencing the area would also help control the foot traffic and better lighting around the building would improve safety. Mayor Pernarowski thanked Ms. Letawski for her presentation, and advised that this matter would be further dealt with under the "Correspondence" portion of this meeting's Agenda (see Resolution No. 048).

Trustee Art Erasmus, Coast Mountains Board of Education – Request for Support Councillor Leclerc declared a possible conflict of interest and vacated Council Chambers.

Trustee Erasmus referred to a letter that was sent to City Council from the Coast Mountains School District Board. The letter referred to a motion which was passed by the Board to reduce the number of trustees from nine to seven.

Trustee Erasmus explained that notice of any proposed changes to the number of School Board trustees goes to all Local Governments in the area and the final decision regarding the number of trustees is made by the Minister of Education. Trustee Erasmus provided some history of the Coast Mountains School District. The number of students in the District has decreased by 50% over the last number of years, and the funding the Board has received from the Province has had a corresponding decrease. The Board proposes cutting one trustee from Terrace and one from Kitimat, reducing the total number of trustees on the Board from nine to seven. The savings would be approximately \$40,000 to \$50,000 per year. Trustee Erasmus acknowledged that the workload per trustee would increase but the Board felt the savings would be of greater benefit to the students in the District.

Mayor Pernarowski thanked Trustee Erasmus for his presentation, and advised that this matter would be further dealt with under the "Correspondence" portion of this meeting's Agenda (see Resolution No. 049).

Councillor Leclerc returned to the meeting.
