Kelsey Wiebe, Terrace and District Museum Society -Mandate Change

Ms. Wiebe thanked Council for the opportunity to present. The Terrace and District Museum Society requested the City's support as they wish to change the Society's mandate in their constitution. The Society will continue to operate Heritage Park Museum, but will also officially seek to establish a downtown museum and digital archival system. This proposed change will provide an opportunity to access grants and funding.

Their current governing mandate reads as follows:

- > To maintain and operate the premises, facilities, and archives of the Heritage Park Museum:
- To preserve and conserve the historical

- buildings and artifacts of the museum;
- > To obtain and preserve historical and heritage artifacts pertaining to the Terrace region;
- To raise money for the furtherance of its purposes by contributions, donations, fees, and grants; and
- > To promote the museum and suitable activities to the public.

The proposed changes to the governing mandate will read as follows:

- ➤ To maintain, preserve, operate, and promote the premises, facilities, and archives of Heritage Park Museum as an interpretive site representing the pioneer era in the region from 1890 to 1930; and
- To establish a dedicated museum and archives to collect, preserve, and display artifacts and documents from Terrace and the surrounding area.

Ms. Wiebe explained that the Society would also like to update their election policies to better ensure institutional stability. Terrace and District Museum Society is proposing to revise section 5.1(a) of their Constitution so that Directors are elected for two-year terms rather than one-year terms.

Mayor Pernarowski thanked Ms. Wiebe for her presentation, and advised that this matter would be further dealt with under the "Correspondence" portion of this meeting's Agenda (see Resolution No. 158).

Diana Penner, United Way

– Better at Home Project

Ms. Penner thanked Council for the opportunity to present, and explained the United Way's Better at Home Project. The Better at Home Project is comprised of volunteers and paid staff from local not-for-profit organizations to help local seniors, allowing them to age with dignity and preventing social isolation. Seniors in Better at Home able to contact communities are their local organization to apply for medical and non-medical support services, and a provider is able to determine which services are needed, such as friendly visiting, transportation, assistance with yard work, and home repair. With the funding provided by the B.C.

government, United Way hopes to have up to 60 Better at Home Communities across the Province.

Ms. Penner explained that United Way will be holding a Better at Home Project Community Meeting on May 15<sup>th</sup>, 2013 at the Happy Gang Centre to determine Terrace and Kitimat's readiness for the Better at Home Project for 2014 and 2015. Ms. Penner distributed an information package and a questionnaire. Ms. Penner requested Council answer and return the questionnaire.
