DELEGATIONS & GUESTS:

Tyler Clarke, Kermodei Tourism Society – 2014 Request for Funding Mr. Clarke thanked Council for the opportunity to present and introduced Kermodei Tourism Society Board President, Seth Downs.

In 2013, Kermodei Tourism participated in various activities such as the Minerals North 2013 Tradeshow and Conference, Prince Rupert Seafest, Riverboat Days, and several tradeshows. Kermodei

Tourism worked closely with organizations such as Travel Northwest B.C. and B.C. Tourism to create a travel package and public information guide.

Kermodei Tourism's goals for 2014 are:

- Updating the Visit Terrace Travel Guide;
- Updating the Northern BC Travel Guide;
- Increasing highway and way finding signage;
- Rebranding Kermodei Tourism;
- ➤ Attending the 2014 Vancouver Outdoor Adventure and Travel Tradeshow;
- Hiring full time summer students;
- Increasing web presence on social media;
- Working toward reinstatement of the 2% Additional Hotel Room Tax; and
- Increasing partnerships, awareness, cooperation, and communication with local stakeholders.

Kermodei Tourism requested funding of \$120,000 from the City of Terrace for 2014, with \$75,000 for marketing, promotion, and other Kermodei Tourism activities, and \$45,000 for costs to run the Visitor Info Centre. Kermodei Tourism generates over \$50,000 each year in revenue through sales from their Travel Guide, the Visit Terrace Guide, and additional Racking Fees. This revenue will go toward supporting other operational costs.

Deputy Mayor Downie thanked Mr. Clarke for his presentation and advised that this matter would be further dealt with under the "Correspondence" portion of this meeting's Agenda (see Resolution No. 427).

Carol Sabo, Ksan House Society – Request for Support for Housing Project Ms. Sabo, Ksan House Society Executive Director, thanked Council for the opportunity to present and introduced Amanda Bains, Director of Finance and Housing for Ksan House Society. Ms. Sabo requested support from the City of Terrace to construct a housing complex. The units would consist of pre-packaged, personalized duplex models with two and three bedroom units for a total of 1,538 square feet per duplex. This project would operate under BC Housing which will provide upfront money and a low rate mortgage. The selected

building units are compact and single level and will not require engineering, contractors, or mechanical consultants. A minimum of 20 units must be constructed for the proposed project to be viable.

This proposed project will require the construction process to be completed largely by volunteers. Representatives from Ksan House Society plan to approach various community groups to gather volunteer support for this project. Ms. Sabo will also be requesting that students from Coast Mountain School District and Northwest Community College provide volunteers.

Ksan House Society requested that the City of Terrace:

- Enter into a long term lease agreement for a parcel of City owned land for a minimum period of 35 years for the purpose of constructing 20 units for individuals and families in the low and moderate income bracket;
- Amend the existing zoning bylaw for the property to allow smaller dwellings to be constructed on that parcel; and
- Provide a \$10,000 grant toward the project.

Deputy Mayor Downie thanked Ms. Sabo for her presentation and advised that this matter would be further dealt with under the "Correspondence" portion of this meeting's Agenda (see Resolution No. 428).
