 - Fourteen (14) signatures were collected from adjacent businesses supporting the application; and

- Three (3) signatures were collected from adjacent businesses stating a neutral opinion on the application.
- b) The R.C.M.P. has stated only minor concerns with regard to the location of the proposed retail store being in close proximity to the Happy Gang Centre, which is noted as a location of ongoing loitering;
- c) The impact on the community if the application is approved is expected to be negligible provided specific site and security improvements are completed; and
- d) The application is in accordance with City of Terrace Policy No. 83 - Liquor and Cannabis Licensing Application Process.
- 2. A public notice of hearing was sent out to the owners of all properties within 100 metres of the subject property and a notice was placed in the local newspaper. The notices gave the date, time, and location of the public input hearing to give the public an opportunity to voice their opinions. The hearing was held at the Council meeting on August 12, 2019.

That consideration during budget deliberations for the 2020 provisional budget include increasing the number of FTE Bylaw Compliance Officer positions to 3 so as to enable active bylaw enforcement in the downtown core and any other areas within the City on an as needed basis and ensure sufficient bylaw staffing to handle complaint enforcement within an acceptable time frame elsewhere within the City;

That consideration during budget deliberations for the 2020 provisional budget include an increase of \$80,000 to the City's legal budget to provide for the retention of a Municipal Prosecutor on an as needed basis to prosecute repeated noncompliant bylaw offenders with the intent to seek appropriate financial compensation, community service, and/or incarceration; and

That the City, in partnership with interested community and or volunteer organizations, facilitate the formation of a volunteer "Court Watch" group to attend, monitor, and report back to Council court proceedings on quarterly basis.
