MINUTES OF THE REGULAR COUNCIL MEETING HELD IN THE MUNICIPAL COUNCIL CHAMBERS ON MONDAY, JANUARY 13, 2020 AT 7:30 P.M.

MOVED/SECONDED to move In-Camera and close the meeting to the public pursuant to Division 3, Section 90 (1) (e) of the Community Charter (to discuss matters relating to property).

REGULAR MEETING:

Mayor Leclerc acknowledged that the meeting was being held on the traditional unceded homelands and territory of the Tsimshian First Nation. She also advised that Council agendas and minutes are available for viewing on the City's home page at www.terrace.ca, Council meetings are webcast on the City's website, and the past minutes have been archived.

DELEGATIONS & GUESTS:

Sargent Mario Cloutier, Terrace RCMP Detachment – Online Crime Reporting Mayor Leclerc welcomed Sargent Mario Cloutier of the Terrace RCMP to the Council meeting.

Beginning next week Terrace RCMP will be moving forward with RCMP online crime reporting for certain offences. The first phase of this project was rolled out in the lower mainland last year. Terrace, amongst other Northern BC communities, is part of phase two.

The types of crimes that can be reported online are limited. The types of crimes include crimes that do not require follow up. If a crime occurs that does not require the RCMP to attend and/or there were no witnesses, this can be reported online. Reporting these crimes online will produce an RCMP file number which is helpful for insurance purposes.

The RCMP will be creating a media release in the spring regarding this new service. They would like to partner with the City to possibly include a small informational pamphlet in the property tax envelopes.

Individuals must have an email account in order to use this service. If someone is not online, and does not have an email account, the crime can still be reported at the RCMP Detachment or by telephone.

Online you will be able to find information regarding exactly what crimes are eligible to be reported through the online reporting service. If a crime is not on the list, you must call the RCMP. If an eligible crime is reported in person or via telephone, the person reporting will be directed to report online if possible as this will be the preferred method.

Crimes that are reported online are reviewed. If follow up is required, an RCMP member will follow up accordingly. If the file can be closed with no follow up, it will closed.

The RCMP will be distributing information pamphlets to the City and Regional District of Kitimat-Stikine.

This new service will not save the RCMP a large amount of time, but it will help reduce time spent dealing with certain crimes. The eligible crimes list may be expanded in the future.

Statistics from the online reporting service will be included in the RCMP quarterly reports moving forward.

Mayor Leclerc thanked Sargent Cloutier for his presentation and advised that the matter would be further dealt with under the "Correspondence" portion of this meeting's Agenda (See Resolution No. 009).

Tyler Wilkes, Terrace Off Road Cycling Association (TORCA) – Request for Resolution of Support Mayor Leclerc welcomed Tyler Wilkes of the Terrace Off Road Cycling Association (TORCA) to the Council meeting.

The Courthouse Trails Project is located behind the Terrace Sportsplex. It is a family and child oriented project that TORCA has partnered with the City on to complete.

Mr. Wilkes requested a letter of support for the project in May 2019. His presentation was referred to staff to further discuss a Partnership Agreement. The draft partnership agreement will be created within the next week.

TORCA has been actively fundraising for this project over the past year. The total budget for the project was \$134,000. As of today, TORCA has obtained \$60,000 of in-kind donations and cash towards the project.

TORCA has submitted an application to the Northern Development Initiative Trust (NDIT) for \$30,000 In order to complete the application TORCA needs to provide them a resolution of support from Council. NDIT will be considering the application at their next Board meeting on January 24, 2020. If TORCA is successful in their application they will have obtained 70% of the required funding for the project. They have also applied to the Terrace Community Forest (TCF) for a grant, as well as holding some upcoming events to further raise funds. The NDIT grant is for a specific section of the pump track.

TORCA is attempting to meet with the Prince Rupert Port Authority, Pembina, LNG Canada, and Rio Tinto.

Mr. Wilkes requested the following resolution of support from Council:

"That the City of Terrace supports the application to Northern Development Initiative Trust from the Terrace Off Road Cycle Association for a grant of up to \$30,000 for the 'Pump Track Construction' project from the Northwest Regional Development Account." There are 4 independent segments of trail within this project. In the event TORCA does not receive full funding, they can build these segments in phases. TORCA is hoping to have the project fully complete by October, 2021.

- ➤ Vary Section 6.4.4.a of Sign Bylaw 2102-2016 and amendments thereto to increase the maximum sign area for a Canopy Sign from 25% to 61% of the vertical area of the canopy; and
- Vary Section 4.18 of Sign Bylaw 2102-2016 and amendments thereto to increase the allowable window sign area from 25% to 100% of the exterior windows and doors of the commercial unit.

2. DEVELOPMENT PERMIT NO. 03-2020 - GLOBAL DEWATERING LTD. (3800 JACK TALSTRA WAY)

It was recommended that Development Permit No. 03-2020 be issued to Global Dewatering Ltd. for the property legally described as Lot B, District Lot 1726, Range 5, Coast District, Plan EPP91844 (3800 Jack Talstra Way), to permit the construction of a 279 square metre steel frame building (shop).
