BYLAW NO. 2284 – 2023

“A BYLAW OF THE CITY OF TERRACE TO AMEND ANIMAL CONTROL BYLAW NO. 2159-2019, AND AMENDMENTS THERETO.”

WHEREAS the Municipal Council of the City of Terrace may regulate, prohibit and impose requirements in relation to animals under the Community Charter, Section 8(3)(k) and Sections 47, 48 and 49, including bylaw enforcement and related matters in Sections 260 through 275.

NOW THEREFORE the Municipal Council of the City of Terrace, in open meeting assembled, hereby enacts as follows:

1.0 Amend Section 1.0 - Definitions as follows.

Change the definition of Possessor to read as:

Possessor – shall mean a person or persons who owns, gives shelter, feeds or otherwise has an animal in his/her keeping.

2.0 Amend **ANIMAL CONTROL BYLAW FEES SCHEDULE ‘A’** of this bylaw as follows:

Under **SALE OF ANIMAL** amend the fees as follows:

- a. Dog (Adult or Puppy) \$300.00
- b. Cat (Adult or Kitten) \$230.00

Under **CREMATION SERVICES** amend the fees as follows:

General Cremations – no ashes returned

- a. 0 – 20 lbs \$55.00
- b. 21 – 50 lbs \$130.00
- c. 51 – 75 lbs \$210.00
- d. 76 – 100 lbs \$240.00
- e. 101 + lbs \$360.00

Private Cremations – ashes returned with a scatter box

- a. 0 – 20 lbs \$165.00
- b. 21 – 50 lbs \$200.00
- c. 51 – 75 lbs \$240.00
- d. 76 – 100 lbs \$275.00
- e. 101 + lbs \$375.00

Private Cremations – ashes returned with an urn

- 3.0 Amend **OFF-LEASH DOG PARKS Schedule ‘B’** by adding the following map schedules.

Off-Leash Dog Park located at Elks Park on Haugland Avenue as shown shaded in grey on Appendix “A of the bylaw.

Off-Leash Dog Park located at Christy Park on Eby Street shown shaded in grey on Appendix “A” of the Bylaw.

- 3.0 This Bylaw may be cited, for all purposes, as "**Animal Control Amendment Bylaw No. 2284 – 2023**".

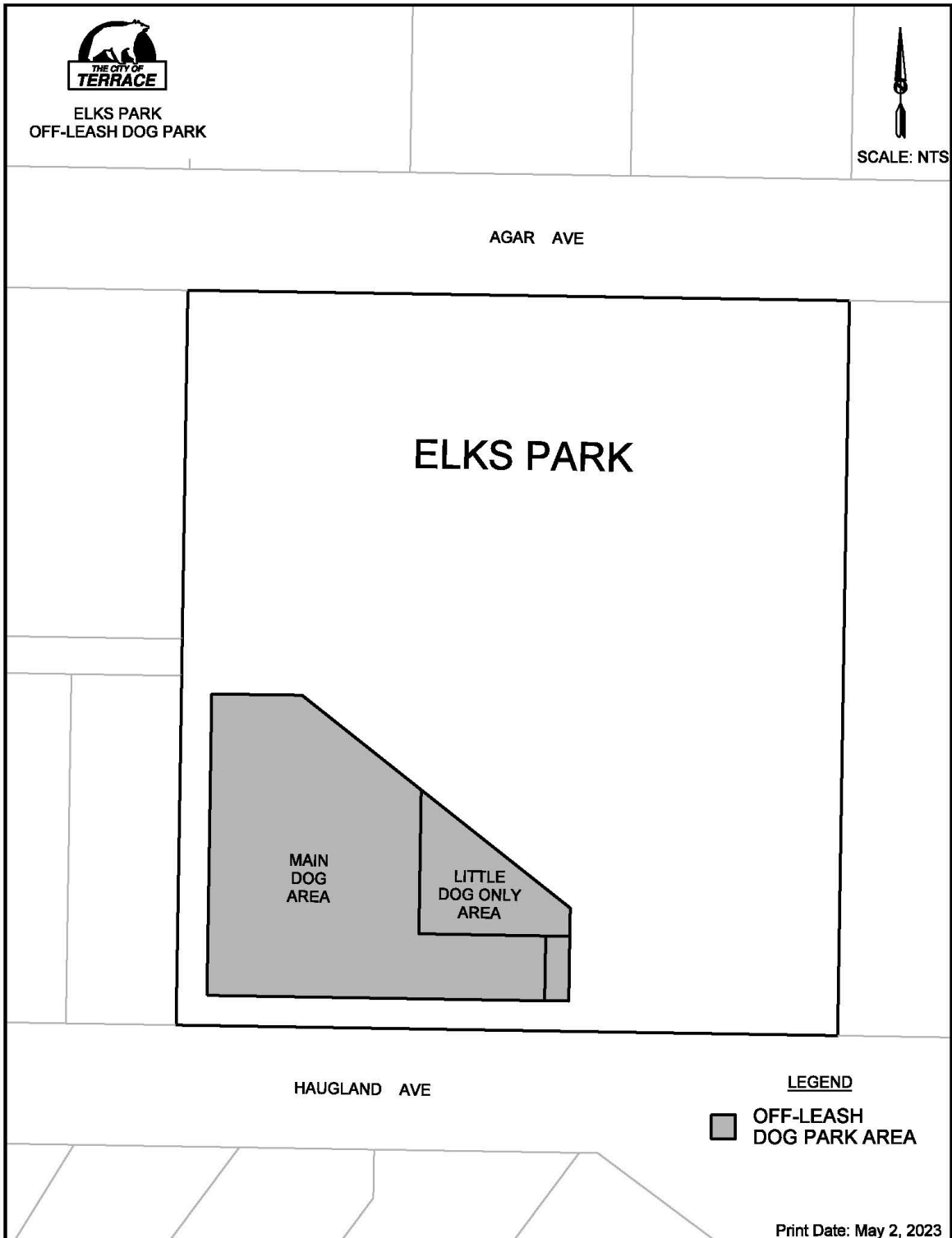
