## APPLICATION FOR DEVELOPMENT VARIANCE PERMIT

**TAKE NOTICE THAT** an application has been made for a Development Variance Permit.

**TAKE NOTICE ALSO THAT** the application affects the property and land within the City of Terrace at #102-4746 Lakelse Avenue shown hatched and in bold outline on the attached map.

## **PURPOSE:**

To vary Section 6.4.3(a)(i) and (b) of Sign Bylaw No. 2102-2016 and amendments thereto to increase the maximum total sign area on a C1-A zoned property with 61.6m of Primary Frontage, from 22.08  $m^2$  to 30.0  $m^2$ .

The subject property is zoned C1-A – Urban Commercial. This permit is being considered to increase the total maximum sign area on the property to allow for a new 2.97 m<sup>2</sup> wall sign above the front entrance of BD Cannabis at 102-4776 Lakelse Avenue.

The proposed **Development Variance Permit may be inspected** in the reception area at the City of Terrace PUBLIC WORKS BUILDING at 5003 Graham Avenue, Terrace, B.C. between the hours of 8:30 a.m. and 4:30 p.m., each day, from Friday, May 12, 2023 to Tuesday, May 23, 2023 excluding Saturdays, Sundays and Statutory Holidays.
