.a Bulk Fuelling Station, Major, limited to one tank with a maximum volume capacity of 150,000 litres, on the property legally described as Lot 1, District Lot 361 and 362, Range 5, Coast District, Plan EPP105420 (4900 Keith Avenue)

To rezone the subject property to permit the siting of a 150,000 litre fuel storage tank in support of a rail to truck transload operation at 4900 Keith Avenue.
