

Official Rules & Regulations – City of Terrace Christmas Lights Contest

No purchase is necessary to enter or to win the 2021 City of Terrace Christmas Lights Contest. The act of entering the Contest constitutes acceptance of the Contest rules & regulations (and all decisions of the City and its agents).

To be eligible, entrants must register at Engage Terrace by providing a username (which will be made public) and an email address (which will not be made public). Entrants may then enter on the contest page (<https://engage.terrace.ca/submit-your-holiday-lights-2021>) by providing a current photograph of their Christmas lights on display, their residential or business address, and the contest category they are entering (all of which will be made public). We encourage entrants to have their Christmas lights turned on December 13 to the 31 to coincide with the voting period. The photo in each category with the most likes will win a prize.

1. Employees, officers, and Council members of the City of Terrace (together, these entities shall be referred to herein as the “City”) are not eligible to win but may enter photo submissions.
2. All entrants hereby consent to the use of his or her name and/or photos of their lighting displays to be used for promotional purposes by the City without prior notice or additional compensation. Contest participants waive any and all rights relative to the collection or use of personal information.
3. Property owners and/or residents may enter their property; however, there is a limit of one entry per property.
4. Entries must be within the City of Terrace.
5. At the end of the Contest, all entries will be reviewed for compliance with these official rules and the winners will be based on the number of votes secured on the Engage Terrace site.
6. Photo entries can be submitted from December 2 to December 31, 2021. Likes (votes) may be placed from December 13 to 31, 2021. Likes will be counted on January 4, 2022.
6. Contest will close on December 31, 2021.

7. The winner of the Contest will be required to sign and return a declaration and release form within 10 business days of notification by the City. If the winner fails to comply, a new winner will be selected. Prizes must be claimed by January 14, 2022, or they will be void.

8. The winner will be announced after the Contest closes and after the winner has been contacted and confirmed by the City.

9. All prizes must be accepted as awarded with no substitutions and have no cash value.

10. There will be four categories – one business category and three residential categories based on location (Bench, Horseshoe/Downtown, and Keith Estates (Southside)). The property with the most votes in each category will receive a \$150 Visa gift card. All contests will be determined by the greatest number of votes on Engage Terrace.

11. The City, in its absolute discretion, reserves the right to make substitutions of equivalent kind or value in the event of the unavailability of any component of the prize for any reason whatsoever.

12. All decisions of the City and its agents are final.

13. The City reserves the right to discontinue the Contest or alter the rules at any time and without notice to contestants.

14. By accepting the prize, the winner agrees to hold the City and its respective directors, officers, employees, and agents harmless against any and all claims and liability arising out of the use of the prize. Winners assume all liability for any injury or damage caused or claiming to be caused by participation in this promotion or use or redemption of any prize. By participating in this promotion, entrants agree to be bound by the official rules and the decisions of the City.

15. This Contest is subject to all applicable federal, provincial, and municipal laws. These Contest rules are subject to change without notice in

order to comply with any applicable federal, provincial, and municipal laws or the policy of any other entity having jurisdiction over the City.
